What is this product?

Type

SANTANDER TARGET MATURITY EURO III (the "Sub-Fund") is a sub-fund of SANTANDER SICAV, a UCITS incorporated in Luxembourg.

Term

The Sub-Fund is established for an unlimited period. The Sub-Fund may not be unilaterally terminated by Santander Asset Management Luxembourg. The Sub-Fund can be dissolved early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund

Objective: The objective of this Sub-Fund is to provide Shareholders with investment growth in the medium term, through a diversified portfolio of fixed income assets.

Investment policy: The Sub-Fund mainly invests up to 100% of its assets mainly in public fixed income instruments in EUR although may also invest in private fixed income in EUR including cash deposits and money market instruments.

The fixed income securities in which the Sub-Fund invests will be issued by entities domiciled principally in OECD countries.

The instruments of the portfolio of the Sub-Fund will have an expected maturity in July 2028 (the "Term Date of the Portfolio"). The Term Date of the Portfolio may be deferred for up to 3 months if the Board of Directors believes it is in the best interests of shareholders.

The Sub-Fund will invest in bonds with a final maturity date on or before the Term Date of the Portfolio. However, the Sub-Fund may acquire bonds with maturity dates beyond the Term Date of the Portfolio. The Sub-Fund credit quality will be at least of BBB- on average rating and may invest up to 50% of its net assets in securities rated lower than Baa3/BBB by major credit rating agencies at the time of the purchase or unrated debt. In the event that an issuer's credit rating is downgraded, the issuer's credit standing will immediately be assessed and appropriate actions for any specific instrument of the relevant issuer within the Sub-Fund may be taken. These actions could include selling the underlying holdings or retaining the holdings to maturity depending on the specific characteristics of the instrument.

The Sub-Fund does not intend to invest directly in equity securities, however the Sub-Fund may hold ordinary equity securities in the event that such ordinary equity securities are acquired by way of conversion. In

the event such conversion occurs, the maximum exposure to equity securities will be 15% of the Sub-Fund's net assets.

Non-EUR denominated currency exposure is limited to 30% of the Sub-Fund's net assets. The Sub-Fund may invest up to 10% of its net assets in UCITS. The Sub-Fund will not hold more than 20% of its net assets in cash and deposits.

The Sub-Fund's portfolio will be built up until 9th of July 2024 and prior to this date the Sub-Fund may invest in Cash, Deposits, Money Markets instruments and short-term Investment Grade Bonds with duration less 18 months. As the Term Date of the Portfolio approaches, the Sub-Fund's portfolio will be progressively composed cash, deposits, short term bonds and money market instruments to preserve the Sub-Fund's Net Asset Value.

After the Term Date of the Portfolio, the Sub-Fund will continue to be managed investing in Cash, Deposits, Money Markets instruments, short term Investment Grades bonds with duration less 18 months.

The sub-fund is actively managed and it is not managed in reference to any benchmark.

SFDR Classification: The Sub-Fund promotes environmental and/or social characteristics within the meaning of article 8 of the Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial sector ("SFDR").

Net asset value calculation frequency: Daily, any Luxembourg Business day.

This is a EUR distribution share class. Unless specifically decided by the Board of Directors, dividends will be paid to shareholders at least on an annual basis.

Intended retail investor:

This Sub-Fund may not be appropriate for investors who plan to withdraw the money within 4 years.

What are the risks and what could I get in return?

Risk Indicator

The risk indicator assumes you keep the product for 4 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Sub-Fund as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the Sub-Fund's capacity to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the final return you may get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Besides the market risks included in the risk indicator, other risks may affect the share performance:

What happens if Santander Asset Management Luxembourg is unable to pay out?

The investor may not face a financial loss due to the default of Santander Asset Management Luxembourg S.A. (the PRIIP Manufacturer). Investors may suffer a financial loss in the event of the insolvency of the depositary, or someone acting on its behalf, which will not be covered by any investor compensation or guarantee scheme. However, this risk is mitigated by the fact that the depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10,000 per year is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 4 year/s. A prior notice of one Dealing Day will be required for subscription, conversion and redemption applications lodged with the Registrar and Transfer Agent in Luxembourg before 16:00 Luxembourg time (the "cut off time") so that any application received before the cut off time of any Dealing Day D will be processed at the Net Asset Value applicable on Dealing Day D+1.
